*I acknowledge and understand that I am enrolling for a 10-month afterschool program, August through May. I understand there are no refunds. The After School Program is paid monthly. I agree to pay the tuition fee by the 15th of each month and know there is a **\$15.00 late tuition fee after the 20th. After the 25th of the month pickup will be halted until your account is brought current. AGDco. does not mail tuition invoices. I understand that I must pay a \$35.00 insufficient funds fee for all returned checks. I understand I will be charged a \$10.00 No Pickup fee if I do not email the studio the day prior to my Childs absence. In the event of an emergency the day of my Child's absence I must notify the studio by 10 AM. I Understand there is a \$15.00 Late Pick Up Fee past 5:40 PM that will begin accruing after two late pickups, one warning, one grace. In the event of a Late Pick Up after 6:00PM the parent will be given one warning; however, after one warning a \$30.00 late fee will apply each time thereafter. These Fees will need to be paid within three days of the infraction. I understand there will be costume fees and recital fees for two plus dances. I understand that if I discontinue mid- season and later register again, I must re-pay a registration fee. In case of an unexpected emergency, I reserve the right to discontinue my payment obligation to Ashley Grimes Dance Collective provided that I notify***

the office in writing, 30 days prior to next month's commitment.

The Shining Stars Informational Packet: Payment Policies & Registration information

Welcome to “The Shining Stars” afterschool dance program! Tuition is paid monthly. The cost of our afterschool program has been calculated by your students' release times and student days in the year. For Public schools it is \$425.00 a month and for Charter Schools it is \$340.00 a month. All Hillsborough County School nonstudents days have been figured into this price and there will be no after school program on these days off. In the event your child is sick or on vacation there is no refunding or discounts for the afterschool program monthly tuition costs. There are no refunds. Tuition is due on the **15th of every month**; there will be a **\$15 late fee** if it is **paid after the 20th**. **After the 25th of the month Pickup will be halted until your account is brought current.** The late fee is strictly enforced, please make your payments on time.

There will be a \$10.00 No Pickup Fee if the studio wasn't emailed the day prior to your child's absence OR in case of an emergency by 10 AM the day of. There will be a \$15.00 Late Pick Up Fee beginning after your second time being late beyond 5:40PM. In the event of a Late Pick Up after 6:00PM the parent will be given one warning; however, after one warning a \$30.00 late fee will apply each time thereafter. These Fees will need to be paid within three days of the infraction.

These payment methods are accepted: Cash, Check to “AGDco.”, Venmo @AGDco, and card reader (Small processing fee). There is a secure drop box for checks to the left of the studio upon entrance. An online payment portal will eventually be set up and you will be notified by email how to use it once available. There is a one-time **Registration Fee** of \$50 per student and \$75 per family. We do offer a 10% sibling tuition discount for aftercare!

Shining Stars Program Policies

Activities: Your child will be on a set schedule. They will participate in fun activities like daily dance

classes, Arts and Crafts, Games, Movies, Snack and Homework time and more! The schedule will be emailed after the first weeks.

Check Out / Dismissal: Upon pick up you will need to check out with one of the Shining Stars staff members Ashley Grimes, Taylor Stoddard, Angelle Wise, Alexis Wilson, Julianna Mendez, Tammy Cain or Marissa Tucker. Parents will need to come into the studio and sign their child out daily. The staff member doing dismissal will notate the time of release.

Absence: Please notify us by email the day prior to your child's absence. In the event of an emergency the day of your child's absence please let us know by 10 AM. There will be a **\$10.00 NO PICKUP FEE** applied for any days we are not notified and go to pick up your child at School.

Sickness: If your child becomes sick during the afterschool program, we will notify you.

Behavior Log: The instructors have a behavior log. In this log they will write down any behavioral issues that may arise with a child and include the date and a brief description. If 3-5 Behavioral issues arise the studio will email the parent to notify them specifics and work together to come up with a solution. In the event of an extreme uncontrollable behavioral issue the studio will contact the parent immediately. As much as we love having all of the dancers attend our program, if there are constant behavioral reports and no resolution or change, we wouldn't be able to continue service.

School: It is required from most schools that you put "Ashley Grimes Dance Collective" authorized to pick up your child on the car rider form.

School Pick Up: We will be waiting to pick up your child from school in the designated area the school establishes for after school programs during their release time. Please remind your child to be timely when going to the pickup vehicle as sometimes other schools are scheduled for pick up directly after. Unfortunately, we will not be able to wait any longer than 10 minutes as it will disrupt the schedule.

Studio Release times: Please be prompt when picking up your child at 5:30PM when the after school program ends. The Late Fees that will be applied have been signed and acknowledged prior in this packet. Circumstantial, extended afterschool may be able to be worked out for an additional charge. Any Fall/Spring Schedule classes past 5:30PM may be registered for at a discounted price if you are a part of "The Shining Stars". Please inquire for more information.

What will your child need to bring and wear?

Food: Your child will need to bring their own snack. There is a refrigerator and microwave provided. There are two water fountains for use at the studio.

Clothes: Pink Ballet shoes, Pink convertible Tights, Black leotard, Black Tap Shoes, Street shoes, and Athletic wear (Leggings, dance shorts, T-shirt any color) . Hair must be pulled back, we will assist them get ready. Please pack the necessary hair supplies. There will be a two-week grace period upon sign up to get the proper dance clothes for classes. After this grace period your dancer will be asked to sit out if they do not have their appropriate class attire.

Where does your child put their stuff?

Cubbies: Your child will receive their own personal cubby with their name on it. They can leave their belongings in it at your discretion.

Electronics Policy: Please let us know if you would like your child's tablets and phones kept at the desk and released upon sign out. When your child is in dance classes or doing certain activities electronics will not be allowed to be used. AGDco. is not responsible for lost items.

Will my child be in the Annual Recital!

Yes! They will be in the "Ashley Grimes Dance Collective" Annual Recital Gala! They will ideally be in two or more recital routines. An informational packet about recital with the dates and fees will go out in the Spring. Recital is highly encouraged. After school ends there may be some rehearsals scheduled thereafter for some of their recital routines before the recital.
